**Show dates:** October 17 through November 11. Gallery will be open Monday-Friday 9am-9pm.

Eligibility: Open to all artists 18 years of age and older. Artwork to be hand-delivered to the Spirol Art Gallery at 742 Upper Maple St., Danielson, CT. Work previously exhibited through NECTAG is NOT eligible. Original 2 and 3 dimensional artwork and sculpture. No reproductions or photography. Wallhung pieces are limited to 784 square inches (example: 28 inches X 28 inches). Works must be wired and ready to hang. No saw-tooth hangers allowed.

**ENTRY**: Each artist may submit up to two entries to be juried for the show.

**ENTRY FEE: \$20** for NECTAG members/\$30 for non-NECTAG members. The single entry fee allows up to 2 submissions. Checks payable to NECTAG. Fees are not refundable.

**Delivery/Drop-off:** October 12 from 10-12n and 5-7PM at the Spirol Gallery. All artwork must be brought to the gallery for jurying.

Jurying and Notification: Jurying will take place on October 13. Artists will receive notification by email immediately following the jurying. Our juror is Ashford artist and art teacher, Debra Gag. In addition to teaching, Debra works with the Kerri Gallery in Willimantic and has experience as an art juror and judge.

**Pick up of declined work:** October 14 from 10-12n and 5-7pm at the Spirol Gallery. A \$5 per day late fee will be charged thereafter.

Opening Reception, Friday October 21 from 5-7pm.

**Awards:** Up to \$1000 in prizes will be awarded at the opening réception on October 21st.

**Our judge** is Eddi Phillips. Eddi served on the board of the Quinebaug Valley Council for the Arts and Humanities and has experience as an exhibit curator.

Closing Reception: Friday, November 11 from 5-7pm.

Pick up of artwork at the exhibit close. November 14 from 10-12n and 5-7pm at the Spirol Gallery. A \$5 per day late fee will be charged until November 21. Any work not picked up by November 21 will become the property of the Spirol Gallery and/or NECTAG.

Sales and publicity: The exhibit will be publicized in print and electronic media and promoted via local radio stations. The Spirol Gallery staff will provide artist contact information for anyone wishing to purchase artwork. All sales will be handled directly by the artist. No commission will be taken by the Spirol Gallery or NECTAG.

Artists agree to allow NECTAG to reproduce and/or publish artwork for exhibit publicity and promotional purposes, unless written refusal is submitted.

**Art Work Insurance:** Neither the Spirol Gallery nor NECTAG is responsible for loss or damage, or other unforeseen events pertaining to the art work. Reasonable care will be taken by the gallery to secure the property and artwork during nonoperating hours.
